GMO FREE White Maize, Sound, fair and merchantable, free from abnormal smell and live pests, of a colour proper to this cereal and the following specifications:

# 6.3 Packing

Bags should meet the following specifications. New polypropylene woven bags of a net content of 50kg each fit for export and multiple handling. The bag must have a heat cut mouth to prevent fibrillation and have a sewn single folded bottom. Bag specifications: Size 62 x 95cm, fabric 105gsm. Construction of fabric must be a minimum of 10 x 10/square inch. Sellers to provide exact specifications and sizes of the bags. Sellers to provide 2% empty bags to be shipped together with the cargo.

#### 6.4 Markings

Bag Markings will be provided by the buyer

#### 6.5 Surveyors:

Weight/quality/packing final at loading and/or delivery point as per certificates issued by a first class superintendence company appointed and paid for by WFP. Packing bags will be of uniform weight, and will be serviceable.

# Superintendents to:

- Have free access to the cargo at the time and place of production and/or loading and delivery;
- Reject any lot showing discrepancies with any contract terms including those i.r.o. quality, packing and marking. Such lot to be replaced immediately at seller's time and expense. The Seller will inform WFP if unable to replace it.
- Approve cargo before transportation to final destination, no cargo to be moved to final destination in absence of this approval.
- Inspect that packing (bags) are made with new strong materials. Packing of poor quality will be rejected by the superintendents and will be replaced at Seller's expense. Superintendents to inspect bag markings as per WFP's instructions.

## 7. General

- I. The parties hereby acknowledge themselves to be familiar with and to be bound by the defaults terms and conditions if applicable as stipulated in: **ACE CONTRACT NO: 1** and generally by the Regulations of ACE.
- II. Neither party shall cede or assign any rights or obligations in terms hereof without the written authority of the other party.
- III. Any broker not possessing actual authority in terms hereof shall be deemed to have contracted on his own behalf.
- IV. ACE will charge an exchange trading commission of 0.05% on all BVO. The commission will be deducted from the contract value before disbursing the funds if ACE is handling the settlement. If an alternative payment method has been selected ACE will invoice 0.025% to each broker
- V. In the event of a dispute arising under this agreement, whether as to the interpretation or the extent of any purported breach, such dispute shall be submitted to arbitration for determination in terms of Regulation 38 of the Regulations of the Exchange. Any determination consequent upon such arbitration shall be valid and binding upon all the parties thereto.
